Temporary Luggage storage service agreement

[1. Items that cannot be deposited]

- 2. Refrigerated and frozen foods
- 3. Animals

[2. usage fee]

Up to 6 hours ¥ 500 ¥ 100 every hour thereafter Up to ¥ 1000 until closing

[3. Inspection of Deposited Items]

If we deem it necessary at the time of deposit, we will confirm the deposited product (including the contents) with your consent. Also, If we judge that there is a suspicion of an article specified in "1.

If there is a reason to judge, please note that we may open and inspect the deposit without obtaining the consent of our customer. I hope.

[4. Usage time]

It will be from 8:00 to 20:00 on the day (deposit until 18:00). No deposits or transfers outside of use hours . After that time, you will be charged an additional daily fee.

[5. When there is no transaction for the deposited goods]

After 15 days including the date of deposit, it is deemed that the customer has waived the ownership of the deposited item, and we will dispose of it and pay the storage fee

[6. Disclaimer]

In the following cases, the Company shall not be liable for damages such as loss or damage to the Deposited Products.

- 1. When the customer deposits the items listed in "1.
- 2. Due to force majeure such as a natural disaster
- 3. When the jurisdiction triggers the seizure of the deposit or the submission of evidence as evidence from the relevant public office
- 4. In the case of a third party
- 5. Other cases not attributable to our company

[7. User Liability]

Damage to us or a third party due to your intentional or negligence or your failure to comply with these Terms Will be responsible for the damages.

[8. Handling of personal information]

Personal information obtained from customers during temporary custody will not be used for anything other than temporary custody.

[9. Changes to these terms and conditions]

The terms and conditions of this agreement can be changed without notice to the customer at our discretion.
